**Payment Policy**

Fox Valley Wellness Center/Midwest Hyperbarics is a cash-based facility. Payment must be made in FULL at time of service. Upon request, we will complete and mail a claim form to you which you can use to submit to your insurance company for reimbursement directly to you. FVWC does not offer payment plans.

We accept cash, checks and credit cards. Checks returned as NON-SUFFICIENT FUNDS will be charged a \$25.00 fee plus the bank fees that are charged to FVWC by our financial institution.

**Cancellation Policy**

We at Fox Valley Wellness Center/Midwest Hyperbarics understand that a person’s schedule can change, necessitating rescheduling of your appointment. We require at least 72 business hours’ notice for new patient appointment cancellations and a 48 business hours’ notice for follow-up appointments. The \$254.00 deposit will be kept for any new patient cancellations that are less than 72 hours and half of the office visit fee will be charged for any follow-up visit cancellations less than 48 hours if we are unable to fill this appointment with another patient. FVWC business hours are Monday – Thursday 7:00 – 5:00, phone hours are 7:30 – 12:00 & 1:00 – 4:30.
